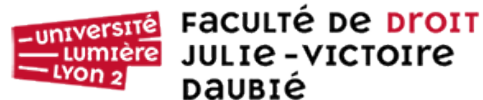


Participant's contract

Article 1 – Definitions

Summer School of University Lumière Lyon 2 : a program offered by University Lumière Lyon2 consisting of a series of lectures introducing the European and International Business Law in Lyon, France.

Participant : anyone that has duly enrolled on the Summer School.

Article 2 – Dates

The Summer School is to take place from July 1 2019 to July 14, 2019.

Article 3 – Eligible participants

The Summer School of University Lumière Lyon 2 is open to anyone that is willing to acquire a basic understanding of the European and International Business Law. No minimum standard is required. Each participant is therefore vested with the responsibility to assess their own capability to make the most of the academic knowledge supplied during the Summer School.

Article 4 – Final registration

Final registration depends :

- on signing the participant's contract, registration form and producing proof of travel insurance coverage (or any insurance coverage deemed equivalent) for the duration of the stay.
- an international transfer of EUR 2000 (see banking information annexed to the present contract) on April 30th, 2019 (midnight) at the latest. A copy of the transfer receipt will have to be sent.

The present contract, registration form, travel insurance coverage and the transfer receipt should be sent to the following address : jean-louis.navarro@univ-lyon2.fr and v.balderas-torres@univ-lyon2.fr on April 30, 2019 (midnight) at the latest.

Any delay or failure to produce any of the aforementioned documents shall invalidate the participant's registration.

Article 5 – Academic Bill of Fare

The objective of the European and International Business Law Summer School Program is to prepare highly qualified business law specialists, who are able to provide legal advice to the transnational and European business environment, to explain the latest business law issues and trends, to analyze and assess business-related legal situations, promptly and effectively deal with the legal problems facing businesses, conduct research and provide suggestions for the law-maker regarding the improvement of business environment regulation.

The total volume of teaching runs up to approximately forty-eight hours, including the Principles and mechanics of business contract law (8h), fundamentals of EU law (8h), e-commerce law & intellectual property (8h), settling international litigations via arbitration (8h), multinationals and cross-border partnerships (8h), international tax system: transfer pricing (8h). The list of categories is non-binding and may be subject to some alterations.

The University Lumière Lyon 2 alone is liable for the standard of academic performance of the Summer School.

Article 6 – Teaching Language

All lectures and/or seminars will be in English and delivered by academics of the University Lumière Lyon 2.

Article 7 – Aggregate fees

The fee to participate in the program will be EUR 2000 per participant. This total amount will entitle each participant to attend all classes. It will also include : Course tuition fees,

Accommodation in a hotel for the whole duration of the stay (from 1 July to 13 July 2019 inclusive), breakfast and lunch, reception at the airport pickup (on June, 30th), group assistant fees, welcoming and closing banquets and entrance fees to several tourist attractions in Lyon.

CAUTION! The total amount does not include the transport charges. Nor does it include the fee charged by the French Embassy, or elsewhere, to issue a visa. Medical insurance and the meals (dinners) not otherwise covered by the program.

Article 8 – Visa

Each participant is solely responsible for undertaking the necessary steps to obtain a visa from the Embassy of France.

Article 9 – Local support

A summer school's responsible who is conversant with/who has a good command of both French and English shall be on permanent duty with the group of participants, chaperon them on any activity relating to the program and shall see to it that the problems that may arise during the stay be solved.

Article 10 – Cancellation

University Lumière Lyon 2 reserves the right to cancel the Summer School in the event of too few participants signing on or any other adverse circumstance (political instability, a major health crisis...) of which the University Lumière Lyon 2 will be sole judge.

If any such problem should occur the participant will be entitled to the full refund of the monies paid by them previously. However, if the participant should initiate the cancellation, reimbursement will not be possible.
